REFERRAL PROGRAM TERMS AND CONDITIONS

1. TERMS AND CONDITIONS

This Referral Program ("Program") offered by KORONAPAY EUROPE LTD ("Koronapay") has been created to reward you, our loyal Customers, ("you," "Referrer," "Participant") for doing what you would already do – recommending us to friends who sign on to be Koronapay customers and proceed with a transfer through the Korona App ("Recipient(s)", "Invitee(s)").

The following Referral Program Terms and Conditions ("Program Terms and Conditions") contain important information about our Program, so please read them carefully. These Program Terms and Conditions are a binding agreement between you and Koronapay and will govern your participation in all offers of this Program. By participating in this Program, you agree to the Korona App and Website Terms and Conditions and the Privacy Policy. You are not authorized to participate in this Program if you do not agree to these Program Terms and Conditions in their entirety.

Koronapay reserves the right to modify these Program Terms and Conditions at any time, at its sole discretion, and without notice to you. Participation in this Program is considered acceptance of these Program Terms and Conditions and any modifications which might be made thereafter. Koronapay may also, in its sole discretion, change, cancel, suspend, or modify any aspect of this Program without notice. Koronapay also reserves the right to disqualify any customers or prospective customers at any time from participation in this Program.

2. HOW THIS PROGRAM WORKS

SUCCESSFUL REFERRALS. A Successful Referral occurs when:

- 1. The Referrer, a current customer of Koronapay who has made at least one transfer through Korona App, receives a Promo Code.
- 2. The Referrer invites Invitees by sharing with them the Promo Code.
- 3. The Recipient(s) of the Promo Code must specify the specific Promo Code in the corresponding field on Korona's App before he /she proceeds with a transfer.
- 4. The Recipient(s) must send the first transfer for an amount greater than or equal to 100 Euro (one hundred Euro) or the equivalent in other currency.
- 5. The transfer is made by the Recipient from a European Union member state to a person in a country outside the European Union. Transfers made from a European Union Member State to another European Union Member State are not covered by this Referral Program.

- 6. The Promo Code can only be applied / used once by each separate Invitee.
- 7. The Referrer cannot invite his / her immediate family.

ELIGIBILITY. To be eligible for participation in this Program:

- 1. The Referrer must be a current customer of Koronapay who has made at least one transfer through the Korona App.
- 2. The Referrer must use a European phone number to make at least one transfer through the Korona App.
- 3. The Recipient(s) must be a new user / customer of Koronapay without having made any previous transfers / transactions through the Korona App.
- 4. Both the Referrer and the Recipient(s) must be at least 18 years of age.
- 5. Koronapay reserves the right to find ineligible any Participant and / or Recipient at its sole discretion.

REFERRAL REWARD CONDITIONS.

Referral Rewards will be granted to both the Referrer and the Invitee. The Referral Reward is granted only if the transfer / transaction by the new customer (Invitee) was successfully credited to the card of the designated receiver or paid out in cash to the receiver ('successful referral').

The Referral Reward for every successful referral is 15 EUR (fifteen euro) each for the Referrer and the Invitee. The maximum Referral Reward for one customer / Referrer is limited to the amount of 300 EUR (three hundred euro).
